**PREFACE**



## SUMMARY

***“Experience grows through being shared”.** This booklet presents a newly-developed expert system that is intended to support planners, managers and consultants of Protected Areas through a system of self-assessment, focused recommendations and a comprehensive knowledge base. The interactive Toolbox provides substantial information on the integrative management of Protected Areas by means of new information technologies. The interactive system is free of charge and is open to everybody on the homepage [www.ipam.info](http://www.ipam.info). Developed in cooperation with international partners and organisations, this expert system aims to be an important backbone for the future development of Protected Areas in Central and Eastern Europe.*

The expert system consists of three components, a self-assessment, a set of standardised recommendations and a knowledge base. The three components aim to provide any information that is necessary to develop a particular Protected Area. The self-assessment is an interactive checklist of questions. They help to identify and focus the problem and the most recent state of development of the Protected Area. The structure of the self-assessment follows the “life cycle” of the Protected Area (pre-phase, planning, ongoing management) and cross checks 25 fields of activity. However, the self-assessment finally results in a Progress Report that points out the deficits in planning and managing the Protected Area and in standardised recommendations. The knowledge base, as an ongoing tool, provides additional materials: reports, projects, organisations, people, best practice, etc. are compiled in an extensive database. Materials may also be added and uploaded by the visitor.

Additionally, a glossary of the most important technical terms is available in five languages. As a first step the Toolbox is available in English, Czech, German, Slovenian and Croatian. Further languages may be added. For the convenience of visitors, a virtual assistant has been created: IPAM Joe is at visitors’ disposal for any information they may need.

# HIGH-TECH FOR PROTECTED AREAS

## Integrative Planning and Management

The protection of areas and sites is one of the most important instruments of modern, anticipatory strategies in nature conservation and in planning for sustainable rural development. Therefore, an enormous increase in the number and acreage as well as in the number of site categories has been registered. The number of Protected Areas in Europe listed by the IUCN (category I-VI) doubled between 1970 (2060) and 1990 (4400). The development of the coherent Protected Area system NATURA 2000 also indicates a rapidly increasing network of sites, meanwhile covering approximately 437,000 square kilometres.

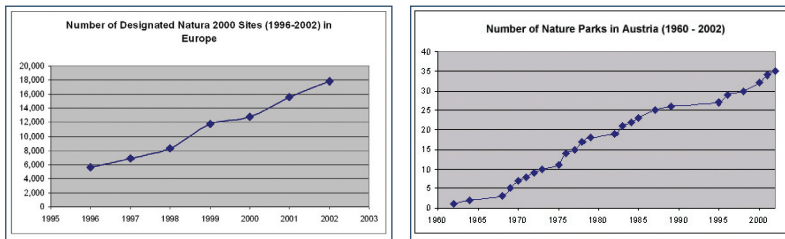


Figure 1: Increase in Protected Areas. At the regional, national and international level, the number of Protected Areas has been steadily increasing over the past few years. Here the development is exemplified by the Natura 2000 sites in Europe and the number of nature parks in Austria.

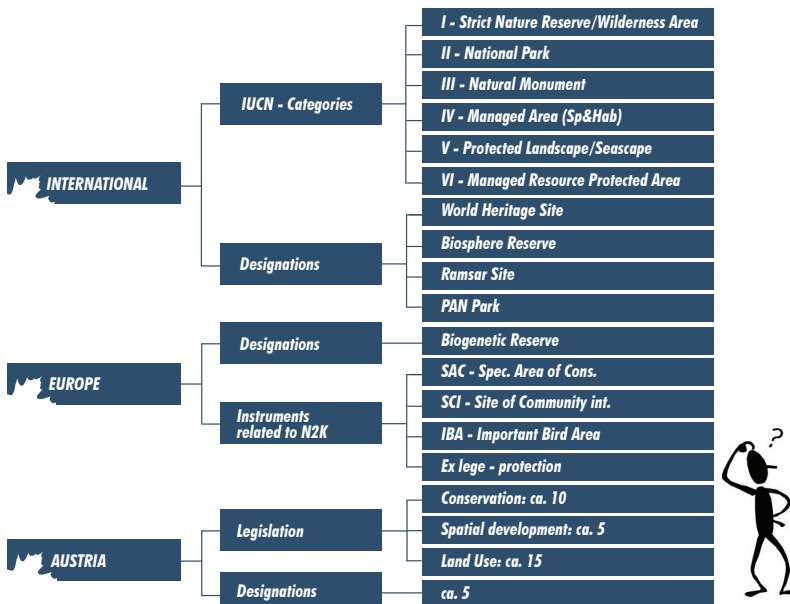


Figure 2: Different Protected Area categories. The variety of different types of Protected Areas sometimes leads to confusion. On the other hand, this variety offers many possibilities of categorising sites to match regional or international requirements.



**The management of these sites** has become a challenge for nature conservation and regional planning policies. For example, within EC-Europe an average of 23% of the land surface is under some type of legal protection. With regards to the acreage, planning a Protected Area has become one of the most extensive planning processes in any modern society. In this process, all three dimensions of sustainability play an important role.

- Ecological dimension (natural heritage, ecosystems, land use regulations, spatial conflicts, spatial development policies, disaster prevention, etc.)
- Socio-cultural dimension (acceptance, involvement, participation, traditions etc.)
- Economic dimension (regional added value, marketing and branding, sponsoring, subsidy systems, etc.)

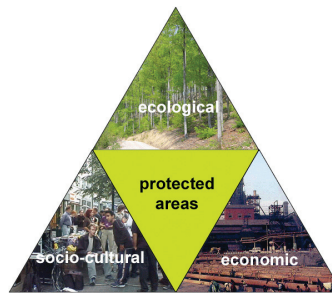


Figure 3: The integration of all three dimensions.

Since planning and managing Protected Areas involves many different legal, administrative and technical realities, the experts in charge have to face an unmanageable variety of tasks.

- Integration of different interests
- Diversity of categories
- Diversity of technical issues
- Diversity of approaches
- International requirements and regional demands
- Permanent lack of resources

In this complex environment, those persons in charge of the Protected Area are under constant pressure to decide, communicate, market, finance and – last but not least – to create benefits.

This is why the demand for highly skilled and highly motivated people has steadily increased over the past few years. Many of these Protected Area managers and planners see themselves overwhelmed by (ir)relevant information, but complain of a significant lack of knowledge. The IPAM Toolbox is intended to bridge this gap and has been developed in order to provide focused information for the questions “what should be done, and when and how should we do it?”



## The IPAM Project

**The Toolbox was developed** in a large-scale Interreg III CADSES – project, involving partners from Central and Eastern Europe. The IPAM Toolbox project (Integrative Protected Area Management by Example of the Alps-Adriatic Region) focuses on the evaluation, harmonisation and development of methods, instruments and infrastructures for planning and managing Protected Areas.

The development of the project took 3 years, from April 2003 to March 2006. A total budget of EUR 2,370,000 was available. Cooperation partners in the project are Carinthia (Office of the Government of Carinthia, Dept. Spatial Planning, AT), Styria (Office of the Federal State Government of Styria, Dept. Nature Conservation, AT), Friuli Venezia Giulia (Regional Directorate of Agricultural, Natural and Forestry Resources of the Autonomous Region FVG, IT), Veneto (Regional Park of Colli Euganei, IT), Czech Republic (Academy of Sciences, Institute of Landscape Ecology, Cz), Croatia (Medimurje County, Department of Spatial Planning, HR) and Slovenia (Ministry of the Environment and Spatial Planning, SL). The leading role in the partnership has been undertaken by the Government of Carinthia, Subsection for Nature Conservation.

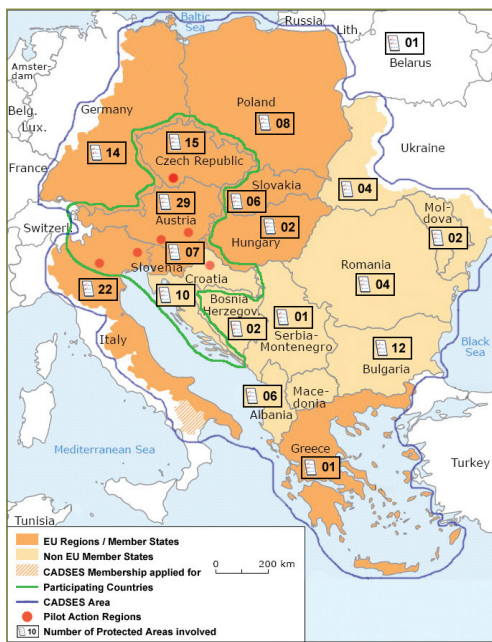


Figure 4: The project area, participating countries, pilot action regions and institutions involved. The project focused on Protected Areas throughout the entire CADSES area. In 6 regions, pilot actions were implemented in order to exemplify best practice in planning and managing Protected Areas. In order to fulfil the user's demands and requirements, some 150 Protected Areas were involved in an inquiry that showed up with exciting results.



**The pilot actions focused** on different aspects of planning and managing Protected Areas. The following activities were implemented:

- Austria, Carinthia: all Protected Areas in Carinthia, specifically Natura 2000 sites
- Austria, Styria: Niedere Tauern, Natura 2000 site (SPA)
- Italy, Friuli Venezia Giulia: Val Alba, Zuc dal Bor (pSCI)
- Italy, Veneto: Colli Euganei, Regional Park
- Croatia, Mura, protected landscape, potential Natura 2000 site
- Czech Republic, Sudeten Mts.: Bohemian Forest / Sumava (National Park, Biosphere Reserve) and Novohradské hory Mts. (Protected landscape)

The expected effects of all these activities are:

- integration of Protected Area management into regional economy and rural development
- improvement of the quality of Protected Area management
- the raising of public awareness of the complex tasks of Protected Area management
- an effort to link Protected Area management with the tasks, instruments and tools of spatial planning and support for the implementation of European standards, policies, procedures and technologies.

The development of the expert system that is presented in this booklet was an essential result of the project "Integrative Protected Area Management" (IPAM). It makes available results and findings of the projects and also of follow-up activities and related activities.

## The IPAM Toolbox

***“We have gathered information, but are lacking in knowledge”*** – this was one of the results of the international inquiry conducted amongst 150 Protected Areas in Central and Eastern Europe. The lack of availability of good know-how and best practice has been pointed out by several different international institutions and therefore the Toolbox is based on explicit demands by:

- IUCN (International Union for the Conservation of Nature and Natural Resources)
- The UNESCO Man and Biosphere Program (United Nations Educational, Scientific and Cultural Organisation)
- CBD (Convention on Biological Diversity).

Technically speaking, such a Toolbox is a knowledge-based expert system, or simply an expert system. It combines expert knowledge (data and rules) with information technologies (database, models, scenario technologies, interactive user interfaces). An expert system will reduce complexity for the user and provide information that matches demand.

- The expertise lies in the system (structure, weightings).
- The user’s requirements are identified.
- The available knowledge is precisely pre-selected (reduced).

The expert system IPAM Toolbox provides a dynamical, interactive consulting process to identify problems, to focus questions and to find solutions. It is addressed to:

- Planners, managers and consultants of Protected Areas
- Mainly issues that are relevant for Central and Eastern Europe
- Individual sites of all relevant international and European categories of Protected Area

Being substantially (co)financed by European funds, the Toolbox is free of charge and provides up-to-date information that is based on an internationally accepted concept. The Toolbox can be accessed on the IPAM-Homepage ([www.ipam.info](http://www.ipam.info)). Furthermore detailed technical documentation is available. The technical solution is composed of a large variety of IT tools (PHP, HTML, SQL, PHP, eZ-publish, Apache Web Server, Linux operating system) and is described in the chapter “Technical solution”.

For the convenience of visitors, many features have been implemented. The system is multilingual. The first edition is English, Czech, German and Slovenian. Further languages will be added. A versioning system stores your information. A Glossary provides definitions and translations. However, the system is quite technical. To prevent visitors from getting lost in depths of the system, a virtual assistant guides them through the expert system. The assistant’s name is IPAM Joe. He is a helpful, friendly person and is at the visitor’s disposal to provide any information.

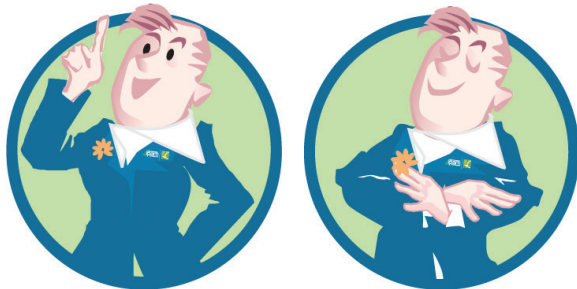


Figure 6: IPAM Joe - the virtual assistant of the IPAM Toolbox. He is at the visitor's disposal for any information. His personality and name are based on a real person who proved to be the spirit of the project IPAM.

## Conceptual Solution

*As has been pointed out above, the mass, sometimes the confusion of available information can be overwhelming. Therefore, expert systems in general and the IPAM expert system in particular are built up in order to provide precisely focused information only. The IPAM Toolbox consists of three components.*

- **Self-assessment.** In a self-assessment procedure, filters are set up in order to primarily eliminate information that is irrelevant for the situation and to (later) rank information by importance. A major “side-effect” of this self-assessment process is a clear positioning of the Protected Area in different fields of activity. In the life-cycle of a Protected Area, 25 fields of activity have been identified and described. Through running through an ideal life-cycle (preparation, basic planning, detailed planning and ongoing management), all fields of activity are covered and therefore provide a helpful framework for determining the Protected Area’s status. In an interactively guided process, the user of the expert system answers a group of key questions to identify the recent situation and the obvious problems.
- **Knowledge base.** In a comprehensive database, various examples of best practice, in-depth information about literature, projects and available data, as well as links and further expertise, are proposed. The information is automatically ranked by requirements derived from the self-assessment, but also can be individually selected. The content of the knowledge base focuses geographically on Central and Eastern Europe, but also presents international standards and approaches. Information on audio-visual media, best practice examples, reports, studies, projects, as well as people and institutions, are available.
- **Recommendations.** On a general level - yet, naturally, closely corresponding to the recent situation of the Protected Area, the expert system provides a set of recommendations. These are automatically generated by the system. The conceptual structure behind these recommendations is the analysis of the difference between those fields of activity that are needed in the particular situation and those fields of activity that have actually been (well) executed so far. The recommendations are provided in standardised reports. They therefore also enable reporting on the progress of the development or management of the Protected Area (time series). The system’s information is illustrated using some examples of best practice and, furthermore, leads to the most detailed information provided in the knowledge base.

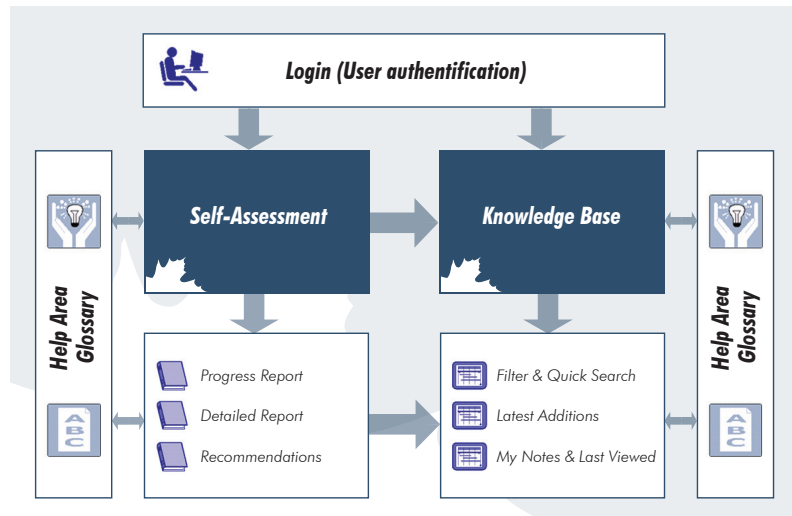


Figure 9: Overview of the Toolbox structure. Do you already know what you are looking for? In that case, you can directly enter the knowledge base and look for the information by setting filters or through the quick search function. The features "Latest Additions" and "My Notes" are intended for your convenience. If you do not know exactly what you are looking for, the interactive consulting process in the self-assessment will provide different reports and standardised recommendations. When entering the knowledge base, filters are set automatically in accordance with your requirements. Additionally, a Help area and a Glossary support your search.

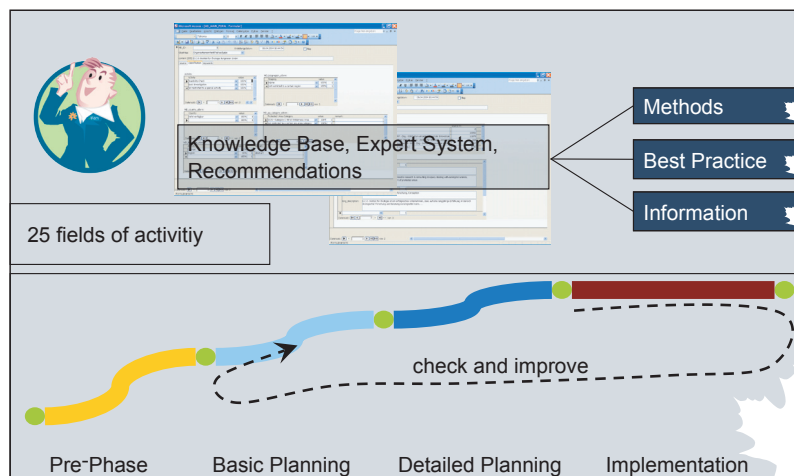


Figure 10: The life cycle of a Protected Area. The Toolbox shows up with 25 fields of activities. They follow the life cycle of the Protected Area, all the way from a pre-phase, through a planning phase, to an implementation phase.

Figure 11: The fields of activity in Protected Area management - an overview. Planners and managers of a typical Protected Area have to run through all the fields of activity. These fields of activity have been developed in close cooperation with international experts and international institutions (IUCN, Europarc, Ramsar Convention, MaB (UNESCO) and are for the first time shown with a comprehensive overview of all obligations included in Protected Area management.



### Technical solution

The **IPAM Toolbox** is based on an Apache 2.0 web server, a widely-used HTTP Server for the internet which runs on a Linux operating system. The clients enter the system with a common web browser. The user identification is implemented at the IPAM portal. The self-assessment and knowledge base are developed with a php application, which is embedded in a HTML code. The content is saved by a MYSQL database.

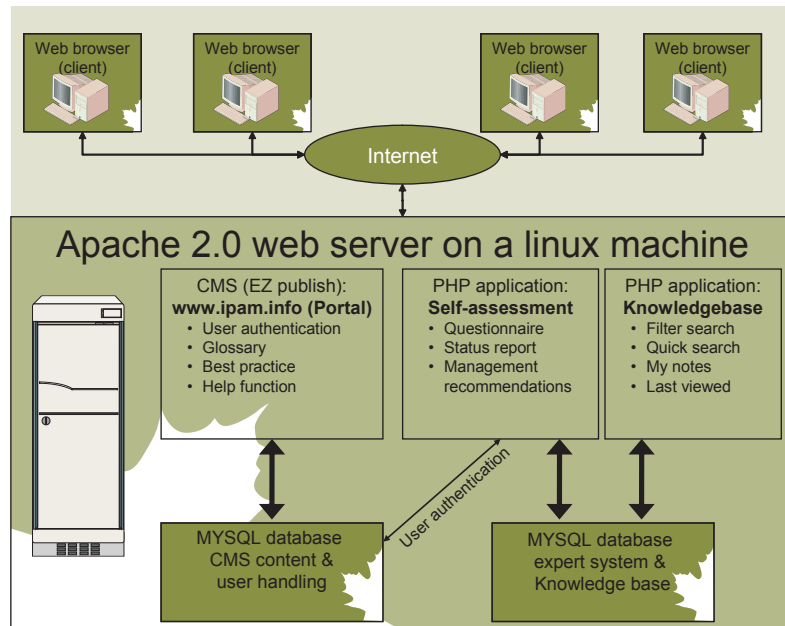


Figure 12: Technical solution of the IPAM Toolbox. For freaks only: the view behind the user's interface shows the confusing acronyms of the most recent IT tools. The ordinary user should not have to bother with MYSQL and PHP.

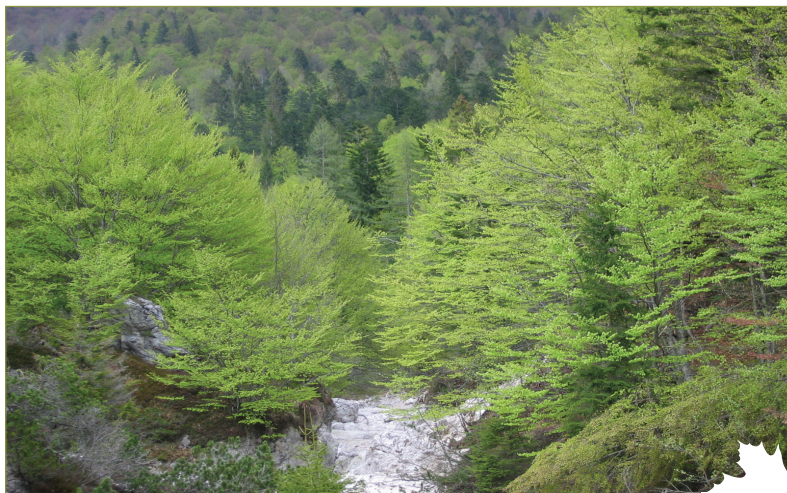


## **MONTAGNA PARK - AN EXAMPLE OF WORKING WITH THE TOOLBOX**

*When you go through the procedure for the first time, be prepared to invest about two hours in order to understand and test the features. You will be guided through the IPAM Toolbox by IPAM Joe, our virtual assistant. He will welcome and support you in using all features of the system. His service is of particular importance when you enter the expert system for the very first time.*

*You won't know Montagna Park. It is a fictional Protected Area, invented only to demonstrate the content and functionality of the IPAM Toolbox. Our test Protected Area has the following attributes:*

- Name of the site: Montagna Park
- Protected Area category: IUCN cat. II
- Country: Austria
- Biogeographic region: Alpine



*Figure 13: Montagna National Park. This early summer beech forest symbolises a fictional Protected Area that was only invented to demonstrate the features of the Toolbox.*

### **Entering the System**

The IPAM Toolbox is embedded in the IPAM Homepage at the following uniform resource locator: <http://www.ipam.info/>

*It is only possible to enter the system after logging in at the IPAM portal. When you enter the Toolbox for the first time, you have to sign up for a user name and a password. After filling in the registration data and confirming it by answering an automatically generated e-mail, you will receive your identification number. With this data, you have full access to the expert system and other services at the IPAM portal.*

Figure 14: User registration. The first time you enter the expert system, you have to sign up. This gives you full access to all features of the system.

*As noted before,* the two main components of the IPAM Toolbox are the self-assessment and the knowledge base. For both tools, you create your personal user profile. This gives you full access to all entries and results that you have already worked out, when you re-enter the system. So you start a new Toolbox session at the status of the previous one.

The user profile contains the following data:

- First and last name
- Address, city code and city
- Country (pull-down list)
- Language (pull-down list)

The data must be filled in only the very first time you enter the IPAM Toolbox. On subsequent occasions, identification will occur automatically through logging in at the IPAM portal. The user profile can be edited at any time. **All information is strictly confidential and is only collected for your own or other users' convenience and / or security.**

Figure 15: Creating the user profile. Identify yourself and you will find all your previous versions properly stored. You will find your name on all reports. You may be sure that all information will be kept strictly confidential. The system provides a high level of security.

**After creating the user profile**, the self-assessment for our example, Montagna Park, can begin. Therefore, a profile for the site has to be created. Four kinds of information should be entered:

- Name of the Protected Area
- Protected Area category (pull-down list)
- Biogeographic region (pull-down list)
- Country (pull-down list)

Figure 16: Creating a site profile. It is important to understand that the system is mainly to be used for individual sites (not for systems comprising several Protected Areas). By selecting these attributes, you set the filters for further processing.

**The data that** was entered into the site profile will be used as filter criteria for further processing (knowledge base). Each Protected Area has a specific combination of attributes. A ranking tool will use this combination to find the most relevant information. Therefore this “early” filter is integrated in the expert system. So you will be provided with very specific and focused information during the online consulting process. In our example, the Montagna Park is an Austrian National Park in the Alpine biogeographic region. In the knowledge base, information from other Alpine National Parks in Austria will be ranked first amongst all further results.

If you are responsible for more than one Protected Area, you can create as many site profiles as you like. In the self-assessment area, the name of the site is always displayed at the top of the page to offer orientation. So, it is recommended that you enter a meaningful / clear name for the site. If you are involved in a planning process, you may also give an interim name to the site. You can edit / renew the site profile at any time.

Some 20 categories of Protected Areas can be selected in the expert system. The system refers to all important international and European categories. The high diversity of national legislation / categories cannot be taken into account. It is recommended to create a new site profile for each Protected Area category.



**A biogeographic region** is an area of the earth that is determined by its distribution of flora and fauna. Within the European Community, 11 different regions are classified. The biogeographic region must also be selected as a filter for the knowledge base.

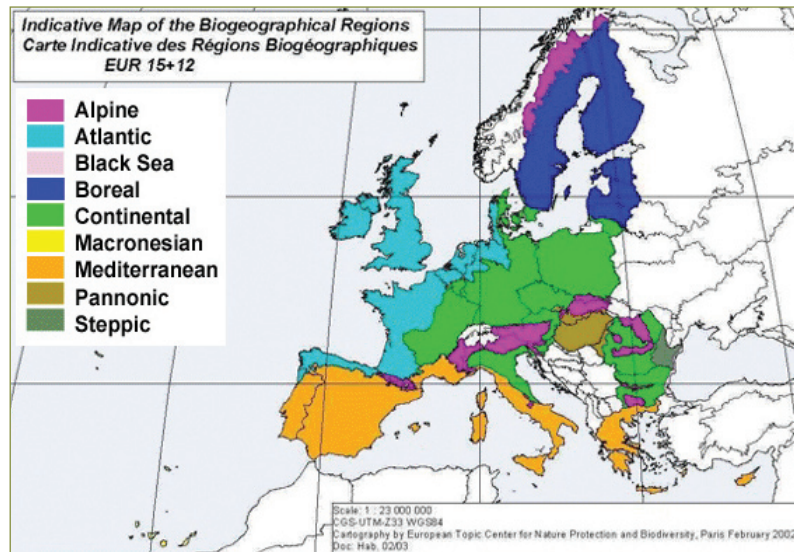


Figure 17: Biogeographic regions in Europe. Natural conditions differ according to region. Select the region of your Protected Area to receive focused information (Source: European Environment Agency 2005).

Selecting the country is the final task when creating the site profile. Countries anywhere in the world may be selected. Countries with similar political, economic and cultural conditions as the one entered will be ranked first in the knowledge base. Due to a stringent concept, you can only select one country. For transborder Protected Areas, we suggest establishing two site profiles.

The site profile can be edited at any time. Modifications of the site profile have a direct effect on the research results.

### **Self-assessment**

Would you like to know about your recent performance in planning or managing your Protected Area? Would you like to precisely name, identify and specifically define your problem(s)? Do you want to know what information is provided by the Toolbox for your specific situation? Then we recommend going through the process of the self-assessment.

**The self-assessment has the following aims:**

- to identify the recent state (phase / field of activity) of your Protected Area
- to open a direct route to suitable, condensed information (knowledge base)
- to enable you to make a comparison with previous stages in the development of your Protected Area or with other Protected Areas
- to gain an overview of all required activities and, on this basis, to plan and evaluate your further activities (improving management effectiveness)

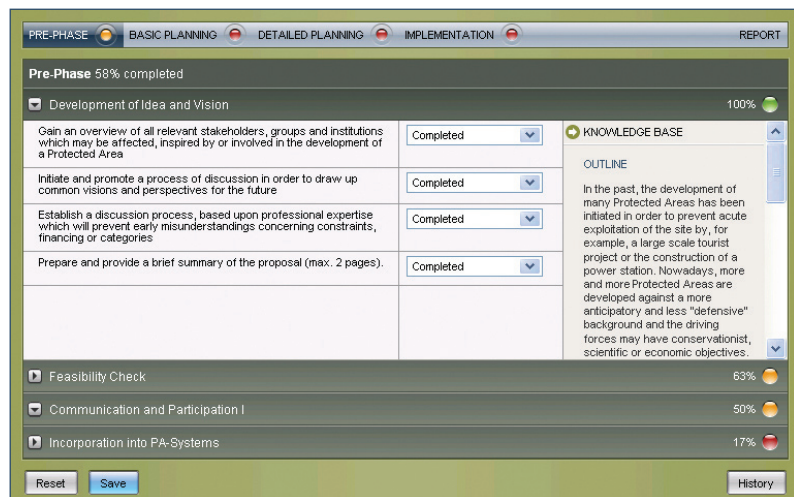
As mentioned above, the management of a Protected Area has been divided into three phases and 25 fields of activity. The phases follow the life-cycle of a Protected Area and differ fundamentally with regard to structure, requirements and activities:

- **Pre-phase:** In this phase, the very first attempts to establish the Protected Area are made. In previous decades, the ideas were quite often instruments to prevent large-scale projects (like industry, roads, etc.). Nowadays many ideas evolve in the context of regional development. Anyway, this early stage is embedded in an unclear situation, within an unstable framework and – usually – in fundamental debates. Roughly estimated, only one out of three ideas survives this phase. Only this can lead to the next step, the planning phase.
- **Basic planning:** It is in this phase that all those activities are pooled which lead to the final establishment of the Protected Area. At the conclusion of this phase, the Protected Area is legally established and / or certified by an (inter-)national label. Covering as they do sometimes hundreds of km<sup>2</sup>, Protected Areas have to be considered as comprising one of the most extensive planning processes in any modern society. Thanks to existing standards and experience, the basic planning phase can be structured quite clearly.
- **Detailed Planning:** In this phase, all those planning activities are carried out which go beyond the implementation of the Protected Area and focus on the demands of conservationists, visitors and stakeholders. Detailed planning is an ongoing process that is closely linked to the ongoing management of the Protected Area.
- **Implementation:** In this phase, all the activities of the existing Protected Area are carried out.

The assessment may be started at any phase. If you represent a “young” site or do not know exactly into which phase your Protected Area may fit, it is recommended that you start the assessment with the first phase (pre-phase) and the first field of activity. You may find some fields of activity which you have never thought about, and which are causing problems in your specific situation.



*When going through the self-assessment, you answer cross-checking questions. You will find your status with regards to phases and fields of activity shown by a percentage value and by traffic lights. If all the requirements have been fulfilled, a percentage value of 100% and a green traffic light are displayed. The visualisation of the processing status of the phases and fields of activity is prepared in a user-friendly way.*



*Figure 18: Self-assessment of Montagna Park. The Toolbox interface shows the pre-phase in Montagna Park in progress (yellow light). The other phases have not started yet (red light). All actions of the field of activity Development of Idea and Vision have been completed.*

The smallest entities in the IPAM Toolbox are actions. Three to six actions form a field of activity. You consider the actions of the field of activity to be:

- not started
- started
- completed

The Toolbox calculates an index between 0% and 100% to indicate how much of your field of activity has been completed so far. The calculation of this index will be accomplished by a matrix in the background.

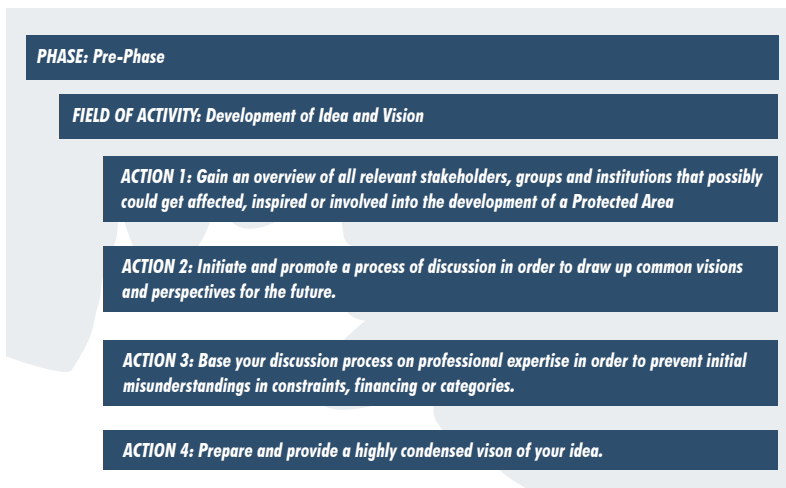


Figure 19: Example of the structure of the self-assessment. The Toolbox segments the management of a Protected Area into 3 phases, 25 fields of activity and 86 actions. Through evaluating fields of activity and actions, you receive an overview of your activities and your performance as planner or manager of the Protected Area.

You go through the self-assessment step by step. For each field of activity a description (function and outline) and additional information are available to the right of the assessment interface. When moving on to the next field of activity, press the button **Save** at the very bottom of the user interface. Your calculation will be updated and your data will be stored. So the assessment process can be interrupted or continued at any time.

## Reporting

After running through the self-assessment, a report shows the results of the consulting process in the form of a summary. Three versions are available:

- **Progress Report:** Overview of the state of progress (aggregate information on your activities)
- **Detailed Report:** Overview of your answers (to check, discuss or store your answers)
- **Recommendation Report:** Set of standardised recommendations as a focal output of the self-assessment

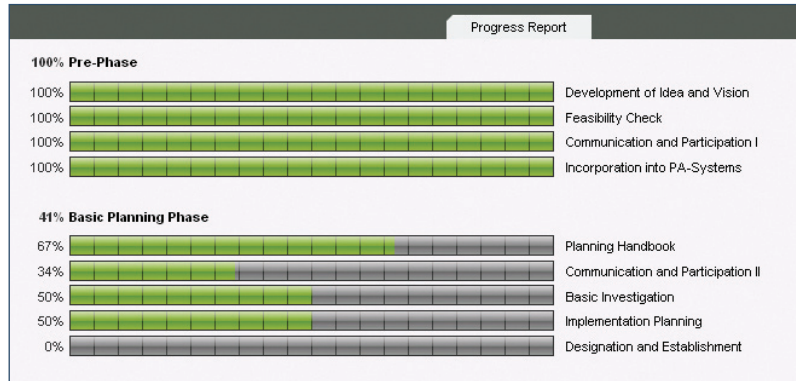


Figure 20: Progress Report. This reporting feature gives an overview of your activities (phases and fields of activity). Their status is displayed by a bar graph and a percentage value. If all the actions of a field of activity have been completed, the bar graph shows a percentage value of 100%.

The Recommendation Report lists all the tasks which should be considered in the further development process of the Protected Area. If the status of all actions of a phase has been evaluated as completed, no tasks will be listed for this phase. The priority status of the action shows the present processing status. A high priority status involves an urgent call for action for the task. By clicking on one of these tasks, more information about them will be shown in a new window. More information about the recommendations is available in the chapter "Additional Information".

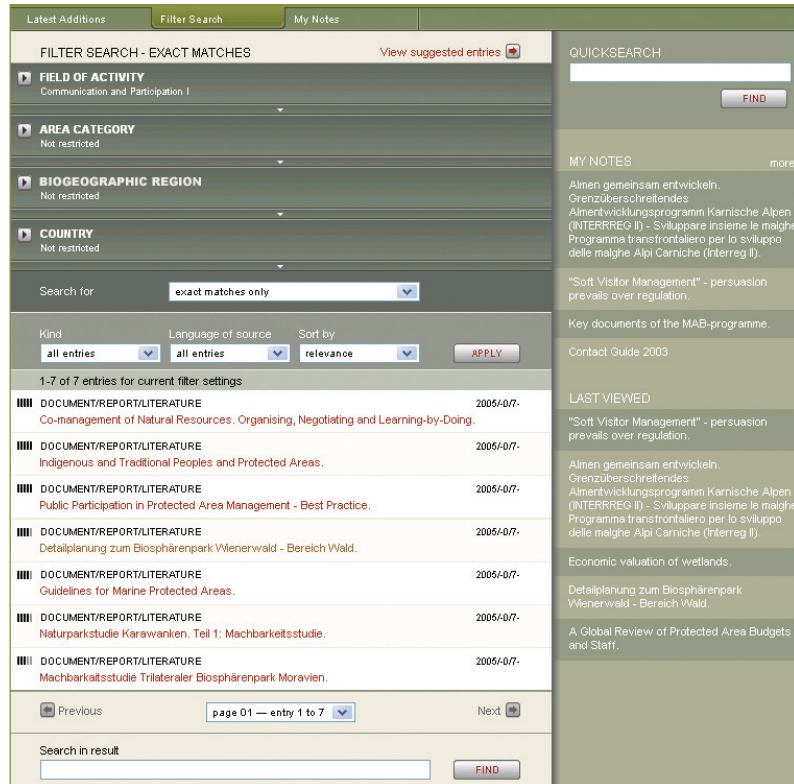

All recommendations are to be understood as very general suggestions and have to be adapted to the individual situation. To do this, refer to the knowledge base.

## Knowledge base

**The knowledge base** is a comprehensive database with information about the management of Protected Areas. Best practice, literature, projects, links and further expertise can all be found in the knowledge base. When entering the base from the self-assessment, you will find your information automatically ranked. You can also perform an individual search: just set the filters individually or enter a keyword for the quick search function.

The search can be made more detailed by setting additional filters (Protected Area category, biogeographic region and / or country). The matches can also be ranked according to:

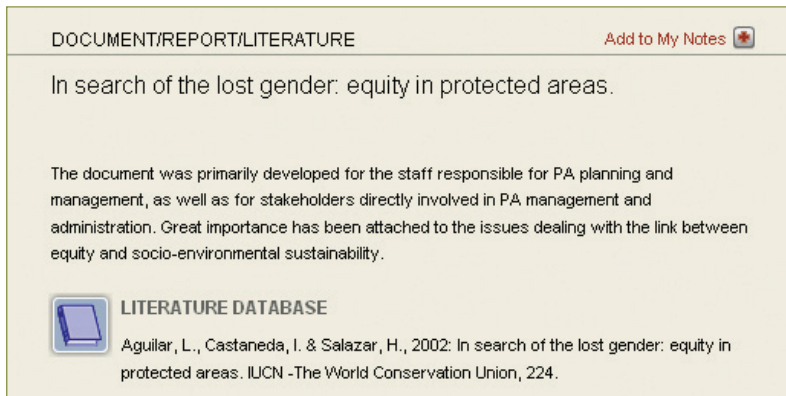

**You also may choose** the preferred language of the matches using a drop-down field. The results can also be ranked by relevance and date of entry. You can visualise the latest entries with the feature **Latest Additions** at the very top of the page. You can also rank the entries by type of source. The types of entry available in the knowledge base are listed above.


By clicking on the search results, you open a new window with detailed information about the entries. Detailed descriptions of the subjects, references, address information and links are displayed. The subjects last viewed are displayed in the right-hand field of the knowledge base.

**There is also** the option of marking some entries for later viewing. A list of these entries is available on the main page under **My Notes**. By clicking on the register at the very top of the page, you activate the detailed documentation of your personal choice. In this window you can sort the notes, remove them from the list or export them.

**Additional features** are a **search in the results** option (ranking within the ranking) and a **quick search** function, which enables you to check the whole knowledge base for terms or keywords.

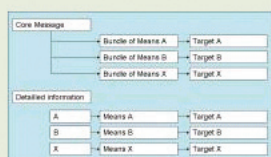

## Communication and participation I

### Communication design

Specify the target groups (check completeness at least three times) and make up order and mode of communication (It is impossible to overestimate the importance of personal meetings)

The means / bundle of means have to be chosen with regards to the target groups. At this stage of discussion it is better to use existing networks, structures and media than to establish new. A clear distinction has to be made between a core message relevant for all and specific information only relevant for specific interests. People should not be drowned in information. The detailed information may be distributed by sectoral or regional requirements.

**Best practice presents** and illustrates good solutions for dealing with specific problems. The best practice is linked to the fields of activities. The information was collected from different Protected Areas in Europe by means of an evaluation of an international inquiry and interviews with experts. The link to best practice can be activated in the knowledge base.

#### Background:

The regional society responsible for the establishment of the mountainous "Gesäuse National Park" in Styria decided to charge a planning team with the elaboration of a Planning Directive. An on-going Feasibility Study has affirmed the operability of a National Park in principle. But there was no common agreement on the dimension of future time and efforts necessary for an effective implementation.

#### Problem/task:

The key issue arising from the intention to start the planning process lay in the complexity of establishing a National Park, which made it difficult for the contracting authority to get an overview of the framework within which the planning process could take place. It is, however, essential to get such an overview, e.g. for tendering procedures.

The following questions indicate the relevant issues:

- what steps, and when, are essential for implementing a national park?
- what level of detail is necessary?
- what should the structure of the planning team look like?
- what are the resource requirements (personnel, timing, finance, technique)?
- what is the appropriate corporate culture?


#### Solution/approach:

With regard to the issues stated above, the innovative approach was found in the design of a so-called Planning Handbook. This central document provides all relevant cornerstones in order to get an idea of developing the Gesäuse National Park. Through defining the relevant steps to be carried out, procedures to be applied, resources required and outcomes to be reached, it was possible to gain a holistic overview of the whole planning process.

It comprises the following core components:

- In general: A short description provides an overview of the suggested time-frame, the recommended corporate culture and planning principles.
- Phases and work packages: For the purpose of a clear and manageable approach, the whole cycle of the planning process was divided into a series of phases subdivided again into consistent, standardised work-packages. For each work-package, objectives, outcomes, methodologies, resource uses etc. were then defined giving the framework for further planning.
- Requirements resources: based on the previous chapter, requirements in terms of human resources have been assessed.
- Open points: due to unpredictable circumstances and conditions, a check-list of open points shows which issues may be expected to arise, thus offering the opportunity to influence/change the planning process.
- Technical aspect: a standardised layout aiming for the prospective mapping of spatial-related data has been created.

**The help area guides** the user through the IPAM Toolbox. It can be accessed using the **Help** button at the very top of the site. The virtual assistant, IPAM Joe, explains functions, most important elements, handling and frequently used terms. Every single button which can be activated at the user interface is described and explained. Screenshots of the selected site support the illustration.

**Site structure - Assessment Centre**

**Purpose:**

On this page the processing status of Protected Areas will be evaluated. In protected area management there exist four phases. Each phase has several fields of activity. These fields of activity contain several subjects. They have to be evaluated under the following categories: completed, started and not started. If a subject is evaluated as being completed, the processing status is shown as 100 percent.

The assessment centre will check the completed tasks and the deficits for the chosen site in Protected Area management. For each field of activity and each phase a percentage evaluation will be calculated and illustrated by traffic lights. If all the lights are green the Protected Area management of the site is far sophisticated.

In the past, the development of more protected areas has been inhibited in order to prevent route exploitation of the site (e.g. for a large scale tourist project, a preservation, etc. Nevertheless, more and more protected areas are developed against a less "intensive" and more participating background. Existing factors may be cultural, historical, scientific or economic interests. Therefore, the establishment of a protected

## MAKE USE OF THE IPAM TOOLBOX

*The Toolbox is a newly-developed high-tech instrument* for sharing experiences and information on the integrative management of Protected Areas. Although the “house” has (so to speak) been built, it still needs to be filled with life. The more people make use of the Toolbox, the more useful it will become. So feel free to use the Toolbox in your everyday work.

- Share your results / experiences: if you have any information to share, do not hesitate to upload it to the knowledge base. Your information will be reviewed and then published in the knowledge base.
- Look for specific information: search the knowledge base if you are in need of specific information.
- Check for new developments: search the knowledge base for recent information (rank by date of entry).
- Check the success of your Protected Area: evaluate the progress of your Protected Area by going through the self-assessment at regular intervals.
- Base the process of discussion on the self-assessment: the cross-checking questions in the self-assessment can form the base for a continuous process of discussion in your Protected Area.
- Make use of the additional features: order the newsletter, post your announcements and visit the chat room (not available yet).
- Document and report any problems: the Toolbox is – of course – work in progress. If you have any complaints or recommendations, do not hesitate to contact the Toolbox team: [expert@ipam.info](mailto:expert@ipam.info).

## **FUTURE PROSPECTS**

***“Experience grows through being shared”.** The IPAM Toolbox aims to be a central platform for information on the integrative planning and management of Protected Areas. The system is to be kept free of charge. Therefore, mainly open source technologies are used. Also the handling of data and information follows open source philosophies: the uploading and downloading of data is done on a strictly non-commercial basis. The Toolbox is to be sustained and enhanced by a network of partners. These may be institutions dedicated to planning, researching, educating or managing Protected Areas.*

One of the first partners to join the network was the University of Klagenfurt. An MSc course in the “Management of Protected Areas” ([www.mpa.uni-klu.ac.at](http://www.mpa.uni-klu.ac.at)) uses the Toolbox as the main support instrument for a two-year postgraduate course of studies. Participants from some ten countries will learn how to make use of the Toolbox and will enter further information into the system. The Toolbox will improve through use.

Furthermore the IPAM Toolbox is to be linked to the worldwide expert system PALNet. The Protected Areas Learning Network (PALNet) is an interactive, web-based knowledge management tool for Protected Area managers and stakeholders, developed and run by IUCN. The intention is to enable Protected Area managers, policy makers and stakeholders to adapt their policies, strategies, and practices to anticipate the threats to Protected Areas and, at the same time, to take advantage of new opportunities. The IPAM Toolbox aims to become the European component of this system.
